AlloyGator Limited and its Licenced Distributors know that you care how information about you is used and shared and we appreciate your trust in us to do that carefully and sensibly. We respect and value the privacy of everyone who visits our website, www.alloygator.com and any of its subdirectories (see Schedule 1) and only collect and use personal data in ways that are described in this Privacy Policy. Please read this Privacy Policy carefully and ensure that you understand our practices regarding your personal information, by visiting our website or purchasing our products, you are accepting and consenting to the practices described in this Privacy Notice.

We take responsibility for the personal information we collect about you, and we aim to be transparent about how we handle it, and give you control over it. If, for any reason you do not agree to the terms of this Privacy Policy, please stop using this website or its sub-directories (see Schedule 1).

INFORMATION ABOUT US

Our website and its sub-directories are owned and operated by AlloyGator Limited, a limited company registered in England under company number 6226009 whose registered address is 61 Heming Road, Washford Industrial Estate, Redditch, Worcestershire B98 0EA. We are registered as a data controller with the Information Commissioner's Office with registered number ZA367813.

YOUR RIGHTS

As a data subject, you have the following rights under The General Data Protection Regulation (GDPR), which this Privacy Policy and our use of your personal data have been designed to uphold:

- The right to be informed about our collection and use of personal data
- The right of access to the personal data we hold about you
- The right to rectification if any personal data we hold about you is inaccurate or incomplete
- The right to be forgotten i.e. the right to ask us to delete any personal data we hold about you
- The right to restrict (i.e. prevent) the processing of personal data
- The right to data portability (obtaining a copy of your personal data to re-use with another organisation)
- The right to object to us using your personal data for particular purposes; and
- Rights with respect to automated decision making and profiling

PERSONAL DATA THAT WE COLLECT

The information we learn from customers helps us personalise and continually improve your

experience at AlloyGator Limited and its Licenced Distributors. We use the information to handle orders, deliver products and services, process payments, communicate with you about orders, products, services and promotional offers, update our records and maintain your account, and recommend merchandise that might be of interest to you. We also use this information to improve our website, prevent or detect fraud or abuses of our website and enable third parties to carry out technical, logistical or other functions on our behalf.

HERE ARE THE TYPES OF INFORMATION WE GATHER:

AlloyGator Limited and its Licenced Distributors may collect personal information which we receive when:

- you use our websites or its sub-directories (including www.alloygator.com and its subdirectories—See Schedule 1)
- you use our services
- you contact us, or
- you are a recipient of our services

This may include information which you provide where you:

- complete one of our forms or receipts
- enter into a contract with us
- enter information on the www.alloygator.com website or its sub-directories (See Schedule 1)
- contact AlloyGator Limited or its Licenced Distributors directly, in writing or by phone, or;
- which is recorded on mail or parcels sent to you by AlloyGator Limited and/or its Licenced Distributors.

We may collect the following types of information:

- your name, address, email address and telephone number(s)
- your company's name, your position in the company; the company's address, company's email address and telephone number
- demographic information such as post code, preferences, and interests
- IP address
- information required to provide you with a service, and details of our services that you have used
- information collected through your use of the AlloyGator website and/or its sub-directories. Please refer to the Cookies section within this policy for more information.

EMAIL COMMUNICATIONS

As a user of our products or services, we will need to send you support communications by e-mail such as transaction messaging, delivery schedules or return confirmations. As long as you are happy for us to do so, we would also like to keep you up to date with other things happening at AlloyGator Ltd and/or its Licenced Distributors which we think you might like to know about; whether it's our latest product announcements, offers or upcoming events. However, if you do not wish to receive communications via email from us, you can find out how to change how you hear from us, or

stop us contacting you, in the section below titled 'How is this personal information used'.

DIRECT MAIL COMMUNICATIONS

We'd like to use your details to keep in touch by post from time to time. Our postal communications are designed to tell you about our latest product releases, promotions and special offers, so that you have exclusive access to our best deals. We use the information we have about you to tailor the content and try and ensure that the offers are as relevant to you as possible. You can tell us at any time that you do not wish to receive postal communications from us. However, this may mean you don't hear about products and promotions or other aspects of our business that may be of interest to you.

Personal data provided to us may also be profiled to help us with targeting strategies. For example, your purchasing data may be used to ensure we don't send you marketing communications promoting a product you have already purchased, or we may use your personal data to find new customers with a similar profile to yourself who may be interested in our products or services.

We may sometimes use third parties to capture some of our data on our behalf, but only where we are confident that the third party will treat your data securely, in accordance with our terms and in line with the requirements set out in the GDPR.

ONLINE INTERACTIONS

We collect and handle information from all visitors to our website, whether you actively provide us with that information or merely browse our websites. The information we collect includes the internet protocol (IP) address of the device you are using, the browser software you use, your operating system, the date and time of access, the internet address of the website from which you link through to our website and information on how you use our websites.

We use this information so we can see how long our website takes to load, how it is used, the number of visitors to the different sections of our website, and what information visitors look at most. We also collect and handle information about how you engage with our promotional campaigns and advertising online, outside of our own websites (for example, on Google, YouTube or on social media). That information is, predominantly, collected through our use of cookies and similar technologies.

Any notices we send to you will be sent to the most recent e-mail address or postal address provided to us by you. The Terms and Conditions in this Privacy Policy together with our Terms and Conditions of Supply are a contract between you and us; neither of us intend that these Terms and Conditions will be enforceable by any other person by virtue of the Contracts (Rights of Third Parties) Act 1999. These Terms and Conditions and all communications between us will be conducted in the English language. The laws of England and Wales apply to these Terms and Conditions. If any disputes arise between you and us (for example, in relation to your order) and you want to take court proceedings, you must do so in the courts of England and Wales.

SOCIAL MEDIA

You may use social media to contact us about your AlloyGator products, or to let people know what you think about your AlloyGator product. We review publicly available social media and online sites to get a better understanding of what people are saying about us, and our products, technology and services and to assist consumers who prefer to contact us through social media. The information we collect from social media and online sites sometimes includes personal information that has been put online and is publicly available. We make sure any information we use is properly credited to its source or is made anonymous.

These online and social media sites may have their own privacy policies explaining how they use and share your personal information. You should carefully review those privacy policies before you use these sites to make sure that you are happy with how your personal information is being collected and shared.

USE OF COOKIES AND SIMILAR TECHNOLOGIES

Please note that we use cookies on the website and its sub-directories (see Schedule 1) to automate and improve the customer experience. Cookies are files that store information on your hard drive or browser so that the website can recognise that you have visited it before. You can, should you choose, disable the cookies from your browser and delete all cookies currently stored on your computer. Please consult the HELP menu of your browser to learn how to disable or delete cookies. Deleting cookies from your privacy setting may prevent you from taking full advantage of some features on the website and/or its sub-directories.

The cookies used on our websites have been categorised based on the guidelines found in the ICC UK Cookie guide. We use the following categories on our websites and other online services:

Category 1: Strictly necessary cookies

These cookies are essential to enable you to browse around our websites and use their features. Without these cookies, services like shopping baskets and e-billing cannot be provided.

Category 2: Performance cookies

These cookies collect information about how you use our websites — for instance, which pages you go to most. This data may be used to help optimise our websites and make it easier for you to navigate.

These cookies are also used to let affiliates know if you came to one of our websites from an affiliate and if your visit resulted in the use or purchase of a product or service from us, including details of the product or service purchased. These cookies don't collect information that identifies you. All information these cookies collect is aggregated and therefore anonymous.

Category 3: Functionality cookies

These cookies allow our websites to remember choices you make while browsing. For instance, we may store your geographic location in a cookie to ensure that we show you our website localised for

your area. We may also remember preferences such as text size, fonts and other customisable site elements. They may also be used to keep track of what featured products or videos have been viewed to avoid repetition. The information these cookies collect will not personally identify you, and they cannot track your browsing activity on non-AlloyGator websites.

HOW AND WHERE DO WE STORE YOUR DATA

The data we collect from you may be transferred to, and stored at a destination outside of the European Economic Area (EEA) who may have different standards of data protection. It may also be processed by staff operating outside the EEA, who work for one of our suppliers or our Licenced Distribution Partners. Such staff may be engaged in the fulfilment of orders, the processing of your payment details and the provision of support services. By submitting your personal information, you agree to this transfer, storing and processing. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy. All information you provide to us is stored on our secure servers. All payments are provided through a trusted third party payment service provider. Please see their terms and conditions for further information on the way they treat your payment details.

HOW WE PROTECT PERSONAL DATA

We know how important it is to protect and manage your personal data. This section sets out some of the measures we have in place. We use computer safeguards such as firewalls and data encryption, and we enforce physical access controls to our buildings and files to keep this data safe. We only authorise access to employees who need it to carry out their job responsibilities. Our procedures mean that we may request proof of identity before we share your personal information with you.

In the unlikely event that we do suffer a security breach which compromises our protection of your personal information and we need to let you know about it, we will do so. However, whilst we take appropriate technical and organisational measures to safeguard your personal data, please note that we cannot guarantee the security of any personal data that you transfer over the internet to us.

HOW IS YOUR PERSONAL INFORMATION USED?

All personal data is processed and stored securely, for no longer than is necessary in light of the reason(s) for which it was first collected. We will comply with our obligations and safeguard your rights under the GDPR at all times. Our use of your personal data will always have a lawful basis, either because it is necessary for our performance of a contract with you, because you have consented to our use of your personal data (e.g. by subscribing to emails) or because it is in our legitimate interests. We use the personal information we collect to provide and improve our services, to provide you with a personalised experience on our site (especially, by offering you content that you may like), to contact you about your account and our services, to provide you customer service, to provide you with personalized advertising and marketing, and to detect fraudulent or illegal activities. Specifically, we may use and retain your personal information as follows:

- Providing and managing your account with us
- Replying to emails from you
- Provide, improve and personalise our services
- Provide access to and use of our services
- Offer you site content that includes items and services that you may like
- Keep track of your basket
- Give you access to your purchase history and other features
- Customise, measure and improve our services
- Provide other services requested by you as described when we collect the information
- We may use geo-location information to provide you with location-based services (such as advertising, making you aware of local service centres for product support, search results and other personalised content)

Contact you about your account and provide you customer service

- Contact you to notify you regarding your account, to troubleshoot problems with your account
- Contact you with updated product information connected with any valid warranty
- Contact you to enforce any agreement we may have with you
- For these purposes we may contact you via email, telephone, text messages and postal mail personalise our advertising and marketing communications
- Personalise, measure and improve our advertising based on your advertising customisation preferences
- Contact you, either via email, telephone, text messages or postal mail to offer you discounts and special promotions and inform you about our Services. We will use the contact information you have provided to contact you by email, SMS text and/or telephone if you have consented to such contact
- Deliver targeted marketing, service updates and promotional offers based on your communication preferences

We retain your personal information for as long as it is necessary and relevant for our operations. In addition, we may retain personal information from closed accounts to comply with laws, prevent fraud, resolve disputes, troubleshoot problems, assist with any investigation, enforce our legal rights and take other actions permitted or required by applicable laws. After it is no longer necessary for us to retain your personal information, we dispose of it in a secure manner according to our data retention and deletion policies.

CHANGING THE WAY WE CONTACT YOU ABOUT PRODUCTS AND SERVICES

We will only send you marketing communications when you have told us that you are happy for us to do so, and you can change the way we contact you by using one of the following options: Opt-In/

START CONTACTING ME

DATA SHARING WITH THIRD PARTIES

We never sell your personal information to anyone and only share it as outlined in this privacy policy.

THIRD PARTIES WHO PROVIDE SERVICES ON OUR BEHALF

We share your personal information with certain third parties who provide services on our behalf. They only have access to the personal information they need to perform those services. They are required to keep your personal information confidential and may not use it for any other purpose

than that requested by us and in accordance with this Privacy Policy.

The third parties who provide services on our behalf fall into the following categories:

- Our distributors, who help us to sell our products in certain countries
- Those helping us to deliver products to you
- Third parties that help us with mailing services, product services and repairs, processing product purchases, financial services, audit services, administrative services, IT technologies (e.g. data storage), legal services, security services and claims
- Third parties that help us to provide services and responses to you
- Third parties that assist us with our marketing, helping us to understand how well our online advertising works, to reach people who are more interested in AlloyGator products, by setting cookies on our websites (more information on this can be found in our cookies policy)
- Social media platforms who serve our advertising on their platforms on our behalf (and who we may securely share your personal information with in order to serve this advertising to both you and/or others).

KEEPING PERSONAL INFORMATION ACCURATE

AlloyGator Limited will ensure that personal information is kept accurate and up to date as far as is reasonably possible. However, AlloyGator Limited relies on customers to ensure that some of the information it holds about them is accurate and up-to-date.
